We must stress the importance of a working partnership & relationship with our NRCS State Conservationist. As your State Association, we always encourage accountability & solution oriented communication among partners & stakeholders.

Important Winter Legislative Announcements

Article 37-1014 of Arizona's revised statutes states that the land commissioner may request on a biannual basis \$30,000 per District and \$60,000 per Education Center for funding from the legislature. That is for two years.

This year, your State Association is pursuing a change in that legislation that will allow the commissioner to request up to \$50,000 per year for each District, and the same for each Education Center. We need you help at the Winter

Legislative Meeting to come and visit your Legislator, and ask him or her, to sponsor this legislation. We will have talking points available for you to take with you on your visit. But we can't do it without each District's participation.

Other legislation that is in line with our policy is a bill that requires the Legislature to consent to any purchase of private land by the federal government. The language requires the Legislature to seek the advice of the affected

Winter Legislative Day- Professional Development Opportunity Open Meeting Law Training

Based on requests from many District Supervisors, Amber Morin, ASLD NRCD Manager, has scheduled an Open Meeting Law Training opportunity to be held on Tuesday, February 18, 2014, in the afternoon of the AZ NRCD Winter Legislative Day.

Natural Resource Conservation Districts (NRCDs) are organized under State and Tribal law. Governed by locally elected & appointed officials, districts evaluate the conservation needs of their respective areas, & create unique partnerships between federal, state &

local agencies to address natural resource concerns. Additionally, NRCDs are administered by the Arizona State Land Department, which is also responsible for ensuring that NRCDs are complying with state laws & regulations.

This is an extremely important educational opportunity for all Supervisors, staff, & volunteers regarding the requirements of adhering to the Open Meeting Law.

Walnut Gulch Experimental Watershed. At this stop, personnel provided information about the Walnut Gulch Experimental Watershed, including its operations & origin in 1951 by the Research Division of the Soil Conservation Service to study the role of watershed treatments on downstream water yield.

Charleston Bridge on the San Pedro River was the third stop on the tour, & everyone gathered to listen to presentations on Federal & Local Planning in the Upper San Pedro Valley from the Conservation Management Branch at Fort Huachuca & the Cochise County Board of Supervisors.

- Jan/Feb 2014 NRCD Formation of Election Board: One Inspector & Two Judges
- February 1, 2014 Election Board to receive ALSD Election Advisory Guide and Election Materials
- Weeks of Feb 23 and March 2 Notice of NRCD Election in Newspaper
- March 25, 2014 Deadline: Submit to ASLD Write-in Candidate Nomination Petition. No Signatures Required.
 - NOTE: copy of candidate's cooperator agreement, voter registration and driver's license should be provided to ASLD
- April 15, 2014 Deadline: for Election Board to Submit to ASLD the Ballot Request Form
- April 24, 2014 Deadline: Submit to ASLD Nominated Candidate Petition 25 Signatures Required
 - NOTE: copy of candidate's cooperator agreement, voter registration and driver's license should be provided to ASLD
- April 25, 2014 Official Ballots Mailed out by ASLD Email Notification of Uncontested Election In This Case, No Election Will Need to be Held
- May 3, 2014 Election Day
- May/June 2014 Elected Supervisors meet to select temporary chair and submit nominees to the ASLD Commissioner for the two appointed
