The National Fish and Wildlife Foundation is administering the Sustain

Our Great Lakes Program, dedicated to sustaining, restoring, and protecting fish, wildlife, and habitat in the Great Lakes basin. The Program will award grants from \$25,000-\$1,500,000 for on-the-ground habitat restoration and enhancement in two categories: (1) Habitat Restoration and (2) Delisting of Beneficial Use Impairments within the Great Lakes Areas of Concern.

Eligible applicants include nonprofit organizations; state, tribal and local governments; and educational institutions. Online pre-proposals must be submitted by February 18, and invited full proposals will be due on April 28. For more information, click here.

Climate Action Plan Hearing

Last week, the Senate Committee on Environment and Public Works held a hearing aimed to discuss environmental policy and President Obama's Climate Action Plan.

Four of President Obama's top climate change officials testified at the hearing, hoping to build momentum behind the President's use of federal agencies to cut greenhouse gas emissions and prepare for future climate change. The panel consisted of Gina McCarthy, Administrator at the U.S. Environmental Protection Agency (EPA), Dan Ashe, Director of U.S. Fish and Wildlife Service (FWS), Nancy Sutley, Chair of the Council on Environmental Quality, and Dan Tangherlini, Administrator of the U.S. General Services Administration.

Republicans voiced opposition to the President's plan, worried that new emission standards will hurt American jobs and raise the price of energy. Democrats outlined the impacts their states are facing due to a changing climate, including oceanic acidity levels, carbon pollution to waterways and fisheries, droughts, and wildfires.

NACD is continuing to track emerging issues and policies related to climate change.
