Nominate Signers for the Ray Federal Credit Union Checking Accounts

The following members were nominated to be signers for the WNRCDs (Tax ID 86-0932080) District and State accounts at the Ray Federal Credit Union: Bill Dunn & Gary Vinson, a motion made by Steve Turcotte to accept and approve the nominations. Francie Meyer seconded the motion. No further discussion. Motion was approved.

Water Protection Fund application

Funding cycle has just ended but still had funds left over. The next funding cycle starts in February. A grant application workshop will be held in the future and people from the district should attend. Funds could be used to reclaim Kearny River Fire land, this land is held by Asarco or the Town of Kearny. Mitigation credit would not be available. Add this topic to the guarterly meeting agenda.

Sun Zia update

Steve went to the pre-filing meeting that was attended by the Attorney General, Arizona Corporation Commission staff, and Sun Zia representatives. Sun Zia plans to do a filing in the next couple of weeks with their final documents and preferred route. Starting October 19, a series of public hearings/tours will be held in Wilcox, Tucson and Casa Grande. This process will be concluded by November 19. The WNRCD district needs to decide if we want to intervene; so, a resolution would be need to be made to appoint someone to represent the district. Could this lay person represent multiple districts or organizations (TNC, Sierra Club, etc)? Bill and Andy Smallhouse will meet with the Sun Zia representatives in next couple of weeks to gather information. Also, need to find out what is their preferred route; is it the BLM recommended route? Another meeting will be scheduled after additional information has been obtained. Add this topic to the quarterly meeting agenda.

Quarterly Meeting (Oct 21) – Location, Newsletter topics, FB Page status, etc

The quarterly meeting will be held at Steve Turcotte's ranch. Need to get a speaker, maybe Sharma Hammons (discussing Project Central, could conduct an estate planning workshop in the future).
